Minutes of the 22nd meeting of the Little Hadham Parish Council (2011 – 2015 Session) held on Tuesday 4th June 2013 at 8:15 p.m. in the Village Hall, Little Hadham.

- **22.1. Absent.** Cllr Gregory [unwell].
- **22.2. Declarations of interest.** Cllr Mrs Piccolo said she had a personal interest in grass cutting at Bury Green as she lived on the Green.
- 22.3. Public session.

A resident of Bury Green said she thought the Council should cut the green as it did the playgrounds.

PCSO Karen Broad spoke about Westland Green. She thought the green looked untidy and the deep ruts on the byroad were a danger to pedestrians and horses. She said she had spoken the Mr Nicholas Maddex, the HCC footpaths officer, and would meet him again on site. Mr Maddex had told her he was willing to deal with the byroad. She thought the byroad should be clearly marked with posts that would prevent vehicles driving onto the rest of the green. The posts would require funding. PCSO Broad thought sheep might be used to keep down vegetation on the green. Any measures would need the agreement of 'Natural England'. The Chairman said he would investigate making the green a 'Special Area of Conservation'. PCSO Broad said she was trying to talk to some of the drivers who had used the byroad and had been abusive to residents. She said anyone damaging posts would be committing criminal damage and could be prosecuted. The Chairman asked PCSO Broad to return when she had more details of what was needed. Cllrs Mrs Piccolo and Mrs Wilkinson agreed to attend the site meeting with Mr Maddex.

PCSO Broad warned residents that there had been a number of burglaries into homes and sheds in Much Hadham. Entry had been at night using fields behind the homes.

- **22.4. Minutes of the Parish Council Annual meeting** held on Tuesday 7th May 2013 had been previously circulated. The minutes were agreed as accurate.
- **22.5. Minutes of the Parish Council meeting** held on Tuesday 7th May 2013 had been previously circulated. The minutes were agreed as accurate.
- **22.6. Matters arising from the minutes.** None.
- 22.7. Playgrounds.
- **22.7.1.** Cllr Williamson said that Mr Foskett had completed the repair work on the playgrounds. Cllr Ms Woodgate reported that a fence post was loose at the Ridgeway playground. Cllr Williamson said he thought it was not dangerous and would be included in the next repair list.
- 22.7.2. Playground inspections. The Clerk said be had booked inspections for the two playgrounds with EHC at a cost of about £100. Agreed.

22.8. Road matters.

22.8.1. Potholes. The Chairman said potholes in Chapel Lane had been poorly repaired and were now almost as bad as before. He would report the pothole near Bridgefoot Farm and the loose manhole cover near the Village Hall.

22.8.2. Vehicles from the side roads jumping the A120 lights. The Chairman said he was still waiting to hear from Herts Highways about a meeting with the relevant authorities. He said he was still getting complaints of bad driving near the traffic lights though not so many as before.

- **22.8.3.** Installation of recycled plastic planters. Cllr Ms Woodgate said the planters had been installed and stocked. She hoped passers-by would help with watering.
- **22.8.4.** Changes to the 351 bus service. Cllr Williamson said that Roadrunner has decided to drop the service. The new contract had been given to Trusty Bus who had bought two second hand buses. The contract would be up for renewal in September 2013.
- **22.9. Footpaths.** The Chairman said a Nature Wander had been arranged for 7th July going to Standon via Westland Green and back.
- 22.10. Flooding.
- **22.10.1.** Cllr said that the multi-agency meeting concerning flooding would take place on 14th June 2013 and he would report its conclusions to the Council.

22.11. Bury Green

22.11.1. To confirm payment of about £100 for one cut of the Green. Cllr Piccolo said Romehold were unwilling to continue cutting the green and she asked the Council to confirm payment of £100 for one cut. Agreed. Cllr Mrs Piccolo said she had written to all the residents asking for a contribution and so far had collected £210 – about 30% of the residents had paid. She thought local residents should make a contribution and not expect other residents of the parish to pay. After some discussion, it was agreed that the Council would pay £240 each year towards cutting the green at £60 a cut. This would leave £140 for further cuts this year. Any further cuts would be paid for by the residents.
